In order to facilitate student exchanges between **Grease Bolts** and **GONNA INSTITUTE OF INFORMATION TECHNOLOGY AND SCIENCES**, the following section provides general procedural information under which the exchange of students between the two institutions will take place. Specific procedures, requirements and duties of the parties in connection with student exchanges shall be set forth in a separate written program agreement to be executed by the parties.

International students studying in the United States will be required to purchase health insurance to meet certain standards such as medical evacuation and repatriation of remains.]
